

Appendix A: Formal Model Proof

Actors

The signaling model consists of two actors. The group, G , sends a signal communicating whether it has high or low salience for an issue. The group's type, t_i , is defined such that $i \in \{L, H\}$ and t_H is a high salience type and t_L is a low salience type. The group's type, or salience level, is private information to the group and is determined exogenously by nature or some player or event not involved in this interaction. The receiver is a legislator, L . The group's type is distributed such that the group is a high salience type (t_H) with probability, λ and a low salience type (t_L) with probability $1 - \lambda$. This distribution is common knowledge and determined exogenously by nature or some other player or event not involved in this interaction.

Actions

The group moves first, anticipating the legislator's rational decision-making. The group can either protest, $p = 1$, or not protest, $p = 0$. After the group moves, the legislator takes an action $a \in \{0, 1\}$. With this action, the legislator informs the group whether she is supporting the group's policy preference. After observing protest, her posterior beliefs are that with probability σ ($0 \leq \sigma \leq 1$), the group is a high salience type (t_H), and $1 - \sigma$, the group is a low salience type (t_L). After observing no protest, her posterior beliefs are that with probability μ ($0 \leq \mu \leq 1$) the group is a high salience type (t_H), and $1 - \mu$ the group is a low salience type (t_L).

Players' Utility

The group has the following utility:

$$EU_{G_i}(a, p, t_i) = a - \frac{p}{t_i} * C_r$$

In this utility function, the group receives a positive payoff if the legislator chooses to legislatively support the group ($a = 1$). If the legislator chooses not to support the group ($a = 0$), the group receives no utility from legislative support. Protest is costly, so when the group protests, it pays a cost that decreases as the group's salience increases, where $0 < t_L < t_H$. This cost decreases as group resource levels increase

where, $C_r = (0, 1)$.

The legislator's utility function is specified as follows:

$$EU_L(a, t_i) = a(t_i - k)$$

When choosing how to respond to protest, a legislator considers the consequences of each of her actions. Supporting a high salience group (t_H) results in a higher payoff than supporting a low salience interest group (t_L). Choosing to support a group costs a legislator, k , where $k=(0,1)$. To ensure that the legislator wants to support a high salience group and not support a low salience group, I assume that $t_L < k < t_H$.

Like Kollman (1998) and unlike Lohmann (1993), this utility function does not explicitly model policy locations. In Lohmann's model, the private information concerns the group's issue preferences. Thus, a modeling of policy locations is essential. In this formal theory, the group's policy preferences are common knowledge and therefore known to the legislator. The private information relates to the group's issue salience. Therefore, modeling policy preferences is unnecessary. Furthermore, in line with Fenno (1978) and more explicitly Fiorina (1974), I argue that legislators are less concerned about representing the entire district or the majoritarian or median voters' preferences in a district. Instead, they are primarily concerned about representing the interests of their reelection constituency. This reelection constituency is a sub-constituency of a legislator's district. It can change over time and depending on the policy issue. This suggests that who the legislator decides to represent depends on which constituent are important for reelection and not necessarily the policy preferences of constituents relative to those of the overall district. A group becomes part of the reelection constituency if and when it is willing to reward or punish legislators on salient issue concerns. Granted, the reelection constituency could also include partisans and the preferences of the group could conflict with these other groups in the reelection constituency. Instead of modeling conflicting preferences with policy locations, these legislative considerations are implicitly modeled in the legislator's utility function in the term, k .

Perfect Bayesian Equilibria

Semi-Pooling Equilibria: There exists a semi-pooling equilibrium that informs the model's main hypothesis. Semi-pooling equilibria occur when one or both players mix between strategies. These equilibria are particularly interesting because they allow for comparative statics, which suggest the

conditions under which legislative support following protest is likely.

Since costs to protest are higher for low-salience groups than they are for high-salience groups, I explore the equilibrium where a high salience type group (t_H) always chooses protest ($p = 1$), a low salience group (t_L) chooses protest ($p = 1$) with probability α , and a low salience group (t_L) chooses not to protest ($p = 0$) with probability $1 - \alpha$.

The legislator would prefer to support a group that provides her with more electoral support without discouraging existing support. Therefore, she never supports the group after seeing no protest ($a = 0|p = 0$), she supports the group after seeing protest ($a = 1|p = 1$) with probability γ , and does not support the group after seeing protest ($a = 0|p = 1$) with probability $1 - \gamma$.

For the legislator's strategy to be sustained in equilibrium, she must be indifferent between supporting and not supporting the group after seeing protest. That is, $EU_L(a = 1|p = 1) = EU_L(a = 0|p = 1)$. This is true if $\sigma = \frac{k-t_L}{t_H-t_L}$, which is derived from equating the legislator's expected utilities of her actions.

$$\begin{aligned} EU_L(a = 1|p = 1) &= EU_L(a = 0|p = 1) \\ \sigma(t_H - k) + (1 - \sigma)(t_L - k) &= 0 \\ \sigma &= \frac{k - t_L}{t_H - t_L} \end{aligned}$$

Updating the legislator's beliefs using Bayes' rule reveals the following:

$$\begin{aligned} \sigma = P(t_H|p = 1) &= \frac{P(p = 1|t_H)P(t_H)}{P(p = 1|t_H)P(t_H) + P(p = 1|t_L)P(t_L)} \\ &= \frac{1 * \lambda}{1 * \lambda + \alpha(1 - \lambda)} \\ \frac{k - t_L}{t_H - t_L} &= \frac{\lambda}{\lambda + \alpha(1 - \lambda)} \\ \alpha &= \frac{\lambda(t_H - k)}{(1 - \lambda)(k - t_L)} \end{aligned}$$

The legislator must also be willing to not support the group after viewing no protest. This strategy is

sustained if $0 \leq \frac{k-t_L}{t_H-t_L}$.

\mu &= 0
\end{aligned}$$

For the group's strategy to be sustained in equilibrium, a high salience group must be willing to always protest. This occurs when $\gamma \geq \frac{C_r}{t_H}$.

Additionally, the low salience group must be indifferent between protest and no protest. This occurs when $\gamma = \frac{C_r}{t_L}$.

Below are the results of this semi-pooling equilibrium. These results are derived from differentiating the equations for α and γ . These comparative statics yield a number of testable predictions with respect to protest and legislative behavior. The first set of results reveals the proclivity for protest by low resource groups.

Result 1: The first equation reveals that as the legislator's prior belief that the group is a high type increases the probability that a low salience group will protest will also increase. The increased likelihood of participation by low salience groups decreases the benefit of the legislator of supporting protest, which sustains the legislator's indifference between supporting and not supporting a group that protests.

Since the legislator prefers to support a high salience group over a low salience group, this result suggests that low salience groups will increase their participation given the increased likelihood that the legislator believes the group is a high salience group.

$$\frac{\partial \alpha}{\partial \lambda} = \frac{t_H - k}{(k - t_L)(1 - \lambda)^2} > 0$$

Result 2: The probability that a low salience group will engage in collective action also increases as the cost for supporting a group increases. Intuitively, this suggests that a low resource group recognizes that with increasing legislative costs for supporting the group's interests a legislator will be more likely to support the group if she thinks the group is a high salience type group. Since the legislator knows that any group that fails to protest is not a high salience group the group protests to increase its likelihood of being represented.

$$\frac{\partial \alpha}{\partial k} = \frac{\lambda(t_L - t_H)}{(1 - \lambda)(k - t_L)^2} > 0$$

Results 3 and 4: The probability that a low salience group protests increases as the salience of both group types increase, respectively. The greater the group's salience the less prohibitive protest is for groups. At the same time, the legislator will benefit more from protest by groups with higher salience than by those with lower salience. Consequently, both the group and legislators benefit from protest as the group's issue salience increases.

$$\begin{aligned} \frac{\partial \alpha}{\partial t_H} &= \frac{\lambda}{(1 - \lambda)(k - t_L)} > 0 \\ \frac{\partial \alpha}{\partial t_L} &= \frac{\lambda(t_H - k)}{(1 - \lambda)(k - t_L)^2} > 0 \end{aligned}$$

The next set of results relate to the probability that the legislator will support a group after seeing protest. The first of these results informs the hypothesis tested in the empirical analyses.

Result 5: The probability of legislative support increases as the costs with respect to the group's

resource capacity increases. This predicts that a legislator is more likely to reward protest by a low resource group than they are to reward protest by a high resource group as the costs of protesting for a low resource group are higher than the costs of protesting for a high resource groups.

Result 6: The probability of legislative support decreases as the salience of the low salience group increases. Even though a legislator will benefit more from protest by a low salience group as the issue salience of that group increases, the legislator will also have to expend more resources for supporting a low salience group with higher issue salience. To be clear, $t_L \leq k \leq t_H$. As the value of t_L increases, so must the value of k .

$$\frac{\partial \gamma}{\partial t_L} = -\frac{C_r}{t_L^2} < 0$$

Pooling Equilibria: There also exist a set of pooling equilibria. In a pooling equilibrium, both group types choose the same action. In these equilibria, the protest signal is uninformative for determining the group's salience level.

The first equilibrium states that if both high and low salience type groups protest, then the best response of the legislator to the group's action is to support the group after seeing protest and not support the group after seeing no protest. The following proof supports this strategy:

The legislator supports the group after seeing protest if her utility of support the group is greater than her utility of not supporting the group.

The legislator does not support the group after not seeing protest if her utility of not supporting the group

is greater than her utility of supporting the group.

The legislator's beliefs are updated after seeing the group's (in)action using Bayes' rule.

$$\begin{aligned}
 \sigma = P(t_H|p = 1) &= \frac{P(p = 1|t_H)P(t_H)}{P(p = 1|t_H)P(t_H) + P(p = 1|t_L)P(t_L)} \\
 &= \frac{1 * \lambda}{1 * \lambda + 1(1 - \lambda)} \\
 \sigma &= \lambda
 \end{aligned}$$

Given the legislator's strategy, the group is willing to always protest if the expected utility of protest is greater than the expected utility of not protesting. Or if the following is true:

$$\begin{aligned}
 EU_{G_H}(p = 1) &\geq EU_{G_H}(p = 0) \\
 1 - \frac{C_r}{t_H} &\geq 0 \\
 t_H &\geq C_r
 \end{aligned}$$

and

$$\begin{aligned}
 EU_{G_L}(p = 1) &\geq EU_{G_L}(p = 0) \\
 1 - \frac{C_r}{t_L} &\geq 0 \\
 t_L &\geq C_r
 \end{aligned}$$

The pooling equilibrium is therefore that both group types protest and the legislator supports the group after seeing protest and does not support the group after seeing no protest if $\lambda > \frac{k - t_L}{t_H - t_L}$ and $t_h > t_l \geq C_r$. Off the equilibrium path, the legislator's posterior belief is that $\mu \leq \frac{k - t_L}{t_H - t_L}$.

There are also several pooling equilibria where both types of group choose to never protest. The legislator's strategy depends on the value of μ as follows:

- If $\mu > \frac{k-t_L}{t_H-t_L}$, then L chooses $a = 1$
- If $\mu < \frac{k-t_L}{t_H-t_L}$, then L chooses $a = 0$
- If $\mu = \frac{k-t_L}{t_H-t_L}$, then L is indifferent between $a = 1$ and $a = 0$

These relationships are supported by the legislator's expected utilities of supporting a group and not support the group after not seeing protest. For instance,

$$\begin{aligned}
 EU_L(a = 1|p = 0) &> EU_L(a = 0|p = 0) \\
 \mu(t_H - k) + (1 - \mu)(t_L - k) &> 0 \\
 \mu &> \frac{k - t_L}{t_H - t_L}
 \end{aligned}$$

The legislator's posterior beliefs, established using Bayes' Rules, are that $\mu = \lambda$.

 \mu = P(t_H|p = 0) &= \frac{P(p = 0|t_H)P(t_H)}{P(p = 0|t_H)P(t_H) + P(p = 0|t_L)P(t_L)} \\
 &= \frac{1 * \lambda}{1 * \lambda + 1 * (1 - \lambda)} \\
 \mu &= \lambda
 \end{aligned}$$

Off the equilibrium path, the legislator's strategy depends on the value of σ .

- If $\sigma > \frac{k-t_L}{t_H-t_L}$, then L chooses $a = 1$
- If $\sigma < \frac{k-t_L}{t_H-t_L}$, then L chooses $a = 0$
- If $\sigma = \frac{k-t_L}{t_H-t_L}$, then L is indifferent between $a = 1$ and $a = 0$

These strategies are sustained in equilibrium if neither group type has incentive to deviate or if $EU_G(p = 0) > EU_G(p = 1)$. The assumption that $C_r > 0$ is enough to sustain the equilibrium if the legislator chooses the same response to the group's action, regardless of the group's action. If L's strategy is to always support the group, then it must be true that

$$\begin{aligned}

 C_r &\geq 0
 \end{aligned}$$

and

If L's strategy is to never support the group, then it must be true that

$$\begin{aligned}EU_{G_H}(p = 0) &\geq EU_{G_H}(p = 1) \\0 &\geq -\frac{C_r}{t_H} \\C_r &\geq 0\end{aligned}$$

and

$$\begin{aligned}EU_{G_L}(p = 0) &\geq EU_{G_L}(p = 1) \\0 &\geq -\frac{C_r}{t_L} \\C_r &\geq 0.\end{aligned}$$

If L's strategy is to never support a protesting a group and to support a group that does not protest then the group will still never protest in equilibrium because

$$\begin{aligned}EU_{G_H}(p = 0) &\geq EU_{G_H}(p = 1) \\1 &\geq -\frac{C_r}{t_H} \\t_H &\geq -C_r\end{aligned}$$

and

$$\begin{aligned}EU_{G_L}(p = 0) &\geq EU_{G_L}(p = 1) \\1 &\geq -\frac{C_r}{t_L} \\t_L &\geq -C_r.\end{aligned}$$

If L's strategy is to support a protesting a group and to never support a group that does not protest then the group will never protest in equilibrium if $C_r \geq t_H > t_L$.

and

These conditions sustain the pooling equilibria that neither group type protests with the legislator's strategy depending on the values of μ and σ , where $\mu = \lambda$ and the legislator chooses to support the group if $\sigma \geq \frac{k-t_L}{t_H-t_L}$ and to not support the group if $\sigma \leq \frac{k-t_L}{t_H-t_L}$.

Separating Equilibrium: Finally, there exists a separating equilibrium. In a separating equilibrium, the high salience group and low salience group pursue different actions. In the separating equilibrium, the high salience group protests, and the low salience group does not protest; the legislator supports the group after seeing protest and never supports the group after seeing no protest. This equilibrium exists if $\mu = 0$, $\sigma = 1$, and $t_H \geq C_r \geq t_L$.

Once again, the legislator's best response to the legislator's strategy depends on the expected utility of supporting the group relative to the expected utility of not supporting the group. After seeing protest, if $\sigma > \frac{k-t_L}{t_H-t_L}$, then L chooses $a = 1$ but if $\sigma < \frac{k-t_L}{t_H-t_L}$, then L chooses $a = 0$. Similarly, after not seeing protest, if $\mu > \frac{k-t_L}{t_H-t_L}$, then L chooses $a = 1$ but if $\mu < \frac{k-t_L}{t_H-t_L}$, then L chooses $a = 0$.

The legislator's posterior beliefs are established using Bayes' rule.

 \mu &= 0
 \end{aligned}$$

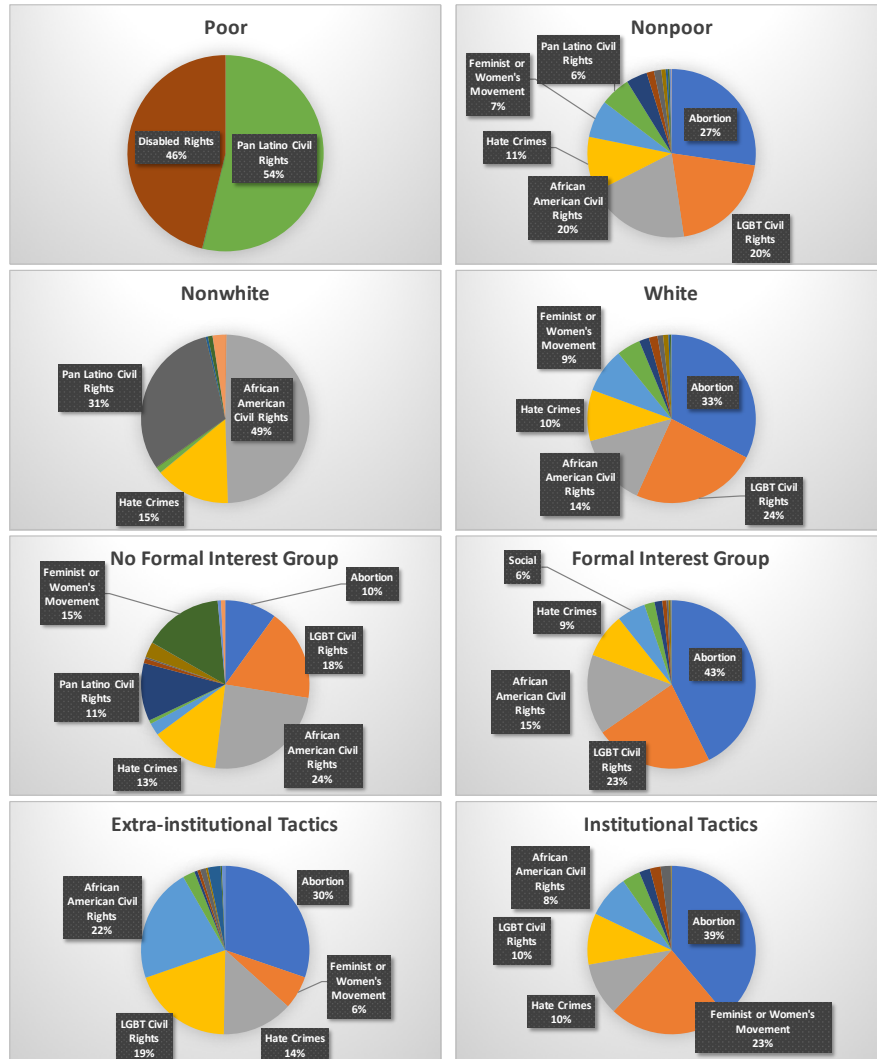
Updating the legislator's beliefs reveals that the legislator's best response is to choose $a=1$ after seeing protest and $a=0$ after not seeing protest. This strategy is sustained in equilibrium. The group has no incentive to deviate from its strategy if $t_H \geq C_r \geq t_L$, where $t_H > t_L > 0$.

Appendix F: Description of Votes

On the next pages is the document used to create the dependent variable, *Support*, from the protest claim. When gathering information for this variable, the first three columns were extracted from the DCA dataset. The DCA data and codebook are available at <https://web.stanford.edu/group/collectiveaction/cgi-bin/drupal/node/17>. Next, www.govtrack.us was searched for the first, final passage roll call vote that related to the description of the protest claim. The roll call bill number was then added to the spreadsheet. Any information in the roll call bill relating to the protest event was recorded in the next column. And finally, the last column includes what vote (yay or no) would align with the protesters' concerns.

For presentation purposes, the *eventid* is not included in Table 11, but that variable was used to merge this dataset with information about the legislator's vote on the roll call vote indicated in the Roll Call Bill column. Each row in Table 11 represents a unique protest event. If a description of protest claim is present in multiple rows, this is because the event happened in a unique time or location from the others (e.g., Rodney King protests occurring in Los Angeles, Chicago, Florida, and other locations).
