

Online Appendix for “At-The-Market” (ATM) Offerings

We present three distinct sections to accompany the manuscript. The first section builds on the analysis of take-down behavior. In addition to exploring (in the main manuscript) the average firm’s cash-savings behavior from ATMs, this appendix shows changes in other “spending accounts” as firms take down shares. The second offers pictorial representation of Ai and Norton analysis of the coefficient(s) on the interaction variable $AI^*Quality$ in the (two) logit(s) [of Table IV]. Last, the third section provides a list of the firms in our sample that conduct ATMs and SEOs in 2012, to provide more detail on the companies conducting these types of follow-on offerings.

Section A.I.

The 65% average cash-savings rate out of ATM issuances (over the first two years following announcement) implied 35% spending. This section illustrates the allocation of ATM issuance proceeds.

Table A.I presents changes in most potential uses of ATM issuance proceeds, along with the actual issuance amount. We do so on a quarterly basis, for the quarter of the ATM announcement as well as two years (eight quarters) after.¹ We also take the “cumulative” perspective: each presented “change in” quarterly variable is the quarter “t” variable value minus the variable value from the quarter *preceding the ATM announcement*. Each variable (with exceptions noted) is also relative to total assets, so that the common scaling allows us to speak to the magnitude of the allocation of proceeds to various categories, in common size terms.

The potential destinations of proceeds we investigate (i.e. the ratios of the following variables relative to total assets) are: accounts receivable, cash, inventories, net PP&E, intangibles, R&D expenditures, advertising expenditures, leverage (short plus long-term debt, which is divided by total assets), and dividends. We also present the quarterly cumulative (ATM) issuance proceeds, relative to assets in the quarter preceding the ATM announcement. Finally, we show the percentage growth in the total assets quarter by quarter.

The results can be summarized easily. Despite several variables showing increases contemporaneously with proceeds taken down, there are only two variables that positively covary with proceeds by a similar *magnitude*; total assets and cash. To illustrate pictorially, we present Figure A.I. The three lines that obviously rise together are the total assets growth variable, the cumulative change in cash variable, and the gross proceeds taken down variable. No other category shows any such consistent pattern. Firms appear to hoard the cash proceeds from ATM issuance, consistent with the precautionary motive for issuing equity (McLean (2011)).

¹ Our analysis indicates that most take-down is executed in those first two years.



Financial Ratios Across Quarters – Uses of ATM Proceeds

Table A.I. presents the mean values of changes in quarterly financial ratios for our sample of ATMs. Each variable listed (except total assets growth) is first scaled by total assets. This ratio is calculated in quarter -1 (the quarter preceding the event) and in quarter "t" (0, 1, ..., 8). The "change variable" is the difference between the quarter "t" ratio and the quarter "-1" ratio. In other words, these are cumulative ratio changes. Total assets growth is the percentage difference between quarter "t" total assets and quarter "-1" total assets. Financials are drawn from Compustat (Fundamentals Quarterly) database. The number of observations for each of the quarters is as follows: Q0: 595 obs, Q1: 488 obs, Q2: 445 obs, Q3: 424 obs, Q4: 400 obs, Q5: 389 obs, Q6: 371 obs, Q7: 345 obs and Q8: 323 obs. All mean values are winsorized at the 1% and the 99% level.

Changes in firm characteristics during the ATM take-down period


Figure I presents the quarterly cumulative trends for the financials' and gross proceeds' percentage changes appearing in Table V. Quarterly cumulative trends span the time period from quarter -1 to quarter +8 when quarter 0 is the quarter of the announcement of the ATM initialization.




Section A.II. Ai and Norton

We present figures of the variation in the coefficient on the $\text{AI} * \text{Quality}$ interaction term (in models 1 and 2 of the logit regression in Table IV of the paper). Each figure shows the interaction effect as a function of the predicted probability of the dependent latent variable. The presentation of the variation of the interaction effects across all predicted probability values is motivated by the Ai and Norton (2004) correction when interaction effects are present in non-linear estimation models.

Section A.III. List of 2012 ATMs and SEOs

This table lists our sample of ATM offerings announced in 2012 (Panel A) and our SEO issues in 2012 (Panel B). Data for ATMs come from The Deal's PrivateRaise and SEOs are collected from SDC. We report the issuer's name and trading symbol, the announcement date and gross proceeds (announced in the case of ATMs and issued in the case of SEOs), including both primary and secondary shares, the four-digit SIC code and the respective 49 Fama French industry.² Four-digit SIC codes are collected from EDGAR.
