




SUPPLEMENTARY FIG. 1 Number of survey participants by country of expertise in the Eastern Pacific and Western Atlantic region (n=36).




SUPPLEMENTARY FIG. 2 Number of survey participants by country of expertise in the Mediterranean region (n=10).




SUPPLEMENTARY FIG. 3 Number of survey participants by country of expertise in the Central Eastern and Southeastern Atlantic region (n=18).




SUPPLEMENTARY FIG. 4 Number of survey participants by country of expertise in the Western Indian Ocean region (n=9).




FIG. 8 Participants' (n=49) perceptions of the economic importance of marine turtle specimens taken in their countries of expertise for commercial gain.
