## **Definition list**

#### Health technology

Defined by the World Health Organization as the "application of organized knowledge and skills in the form of devices, medicines, vaccines, procedures and systems developed to solve a health problem and improve quality of lives."

#### Health technology assessment (HTA)

Health technology assessment (HTA) refers to the systematic evaluation of properties, effects, and/or impacts of health technology. It is a multidisciplinary process to evaluate the social, economic, organizational and ethical issues of a health intervention or health technology. The main purpose of conducting an assessment is to inform a policy decision making.

#### Hospital-based health technology assessment (HB-HTA)

Performing HTA activities tailored to the hospital context to inform managerial decision on different types of health technologies. It includes the processes and methods used to produce HTA reports in and for hospitals.

#### AdHopHTA

An EU funded research project that developed three products for improving the practice of HB-HTA. The three products are a Handbook, Toolkit and Database.

#### The AdHopHTA database

A database created by the EU funded project AdHopHTA in which HB-HTA information (especially HB-HTA reports) can be stored.
