A Reporting Standards

A.1 Hypotheses

The hypotheses to be tested are summarized in the main text of the paper (Table 2) and were registered with EGAP (Registration ID 20200819AA) prior to the collection of data. Our study registration including a pre-analysis plan is available at https://osf.io/aq9dv

A.2 Subjects and Context

Eligibility and exclusion criteria: The sample for our survey is an online convenience sample recruited via Lucid Marketplace targeted to adults aged 18-45 in heterosexual partnerships with at least one child under the age of 12 in the United States. These characteristics of the target sample were intended to closely mirror the characteristics of the couple described in the hypothetical profiles in the conjoint experiment. We exclude respondents who do not meet this criteria. We set a target quota of 50% female identifying and 50% male identifying respondents for the sample.

Recruitment Procedure: Respondents were recruited online via Lucid Marketplace to complete the survey on the Qualtrics platform in accordance with the targeting criteria and quota described above. Recruitment dates: The survey was live and received responses from 19 August 2020 - 22 August 2020.

Setting: Online; respondents recruited from across the United States

Response Rate: Lucid Market place estimates an average industry response rate of about $5\%^1$

A.3 Allocation Method

Each survey respondent completes 4 choice tasks for which they view 4 pairs of profiles (8 total profiles). Each profile has 5 attributes, which can take 2 or 3 possible randomly assigned values. Each attribute value is assigned with equal probability, without any blocking procedure or restrictions.

Figure A1 demonstrates the frequency with which each attribute value appears across all 15,504 possible profiles (8 profiles per 1938 respondents)

Figures A2 and A3 diagnose balance by two pre-treatment covariates we use in our analysis (gender and gender ideology) by comparing the mean levels of these covariates across the conjoint attributes.




Figure A1: Frequency of Attribute Values across Profiles Frequency of Attributes




Figure A2: Marginal Mean of Gender Covariate Across Attribute Values Gender (Female=1)




Figure A3: Marginal Mean of Gender Ideology Covariate Across Attribute Values

A.4 Treatments

The treatments in this study comprise randomly varied attributes of profiles viewed within a conjoint experiment. The attributes and possible values are summarized in the main text of the paper in Table 1.

A.5 Results

Outcome Measures and Covariates:

We use the following two outcome measures:

- 1. Whether profile was chosen (binary forced choice outcome)
- 2. Perceived fairness of situation described in profile (5 point Likert scale)

We assess conditional effects by the following two individual level attributes:

- 1. Self-identified gender (binary)
- 2. Gender ideology (binary, coded as "high sexism" if higher than median score on responses to Modern Sexism Scale questions, "low sexism" otherwise)

Participant Flow

- **5266** participants entered
- **3691** participants passed the pre-screening
- **2059** participants completed the survey and were assigned the randomized treatments as part of the conjoint survey experiment
- We analyze data from a total of **1938** respondents, after dropping those respondents who did not satisfy criteria of being in a heterosexual partnership with at least one child under 12 based on responses to survey questions answered pre-treatment




